





# Safety Management with the Selection and Concentration strategy

New chemicals being produced constantly,
means of transportation becoming faster and
high-rise buildings getting higher...
As the speed of growing economy and industries,
the risks from facilities and equipment are becoming large, complex,
integrated and advance, boiling down to significant changes in safety
and health environment in workplaces.

In this regard, KOSHA has set its goal as cutting the number of occupational fatalities by half. Analyzing the cases and key contributors of occupational fatalities, we select falls and caught in-betweens as top 2 malignant fatal accidents and focus all our resources on addressing this.





We intensively examine sites without scaffoldings and safety handrails and encourage construction sites to build safety facilities to prevent fall accidents.





We examine manufacturing factories using dangerous machines and tools and encourage them to take essential safety measures and maintain safety facilities to prevent caught in/between accidents.



## **Reduced Accidents and Deaths**

We focus on intensive management of major high-risk workplaces and facilities where many occupational fatalities occur to find the causes of accidents and provide optimal solutions.

On-site Patrol Check for Prevention of Accidents and Fatalities We strive to prevent workplace accidents and deaths by performing On-site Patrol Check on dangerous sites, machines, and tools, specifically targeting to prevent 'caught in/betweens' in manufacturing and 'falls' in construction industry.

Management of the safety of chemical facilities


We encourage systematic management of the soundness of chemical facilities by grasping the danger and risk of old chemical facilities and suggesting improvement measures.

Provide close investigations into major accidents

We provide a close investigation and identify the root cause through in-depth analysis when a major accident occurs and encourage improvements in laws and systems to prevent any recurrence of such accidents.

Operating Accident Monitoring & Response Center We are operating the accident monitoring and response center to grasp and notify an accident in the workplace promptly through 24-hour real-time monitoring and cope with the accident immediately.

On-site Support for Prevention of Suffocation Accidents We strive to prevent suffocation accidents by providing technical assistance as well as proactive prevention device services to workplaces that are highly vulnerable and exposed to suffocation risks.

## **Statutory and Policy Projects**

Safety Certification and

To thoroughly implement the Occupational Safety and Health Act and the government's occupational safety and health policy, we are carrying out projects to enhance a prevention project's execution power and establish a worksite's self-regulated safety and health system.

Review and confirmation of harm and hazard prevention plan	We review hazard and danger prevention plans for workplaces or construction sites prone to high-risk accidents to examine and confirm preliminary safety.	
Operate risk assessment consulting and the accreditation system	We provide risk assessment consulting so that employers can identify, evaluate, manage, and improve their worksite's hazard/risk factors on their own and operate the outperforming worksite accreditation system.	
Provide technical guidance for safety and health coexistence partnership programs	The client company supports subcontractors, and KOSHA helps subcontractors to improve their safety and health management capabilities, which establishes a system where the prime contractor's safety and health techniques are transferred to subcontractors.	
Operate Notification Service on Chemical Exposure Information	We provide a service through which every worker can check the type or chemicals they need to handle as well as the level of chemical exposure involved in his/her work process.	
Projects to protect employees serving customers	For occupations at high risk of emotional labor, we provide support to improve the coping ability of employees serving customers and establish an organizational prevention system.	
Review and confirm process safety management	Review and confirm Process Safety Management (PSM) report written and submitted by business owners in order to prevent major occupationa accidents such as leakage of hazardous substances, fire, explosion, etc.	

We conduct safety certification and inspection to fundamentally ensure

the safety of machinery, tools, protective devices, and PPEs in industrial

sites and check their safety performance during use.











## **Financial and Privately Entrusted Projects**

For small and medium-sized enterprises, we provide financial assistance and technical support through related private entrusted bodies to create a safe and comfortable working environment and protect workers' health.

Safety Investment Innovation Initiative	Financial assistance is provided to workplaces with less than 50 permanent workers to support them change old hazardous machineries and equipment (scissor lift, mobile crane, lift, etc.) and improve their hazardous process using Korea's PPURI technology (root technology).

## **Assessments on Public/Private Institutes**

Assessment projects on public and private accident prevention institutes are implemented in order to secure safe workplaces and to improve the level of OSH services provided to businesses.

Evaluation on the level of safety activities by public institutes

We aim to provide safe workplaces fulfilling the level of public expectations and promote early stabilization of safety management environment of public institutes through evaluation on the level of safety activities.

Safety Management Rating (Safety-Cap) System of Public Institutes We encourage to improve the level of safety and establish the safety culture in workplaces by evaluating the safety-related capabilities, safety levels, safety achievements and values of public institutes.

Evaluation of private accident prevention institutes

We aim to encourage self-regulatory improvements on the level of OSH services delivered to workplaces by objectively evaluating the current conditions and competence of work performances from the private accident prevention institutes and reflecting outcome of the evaluations in order to gradually manage the institutions.

#### Focused Training on Prevention of Accidents and fatalities

We operate safety and health training programs, in a pursuit of preventing so-called Top 4 malignant fatal accidents, i.e., fall, caught in/between, crash, suffocation, as well as accidents and fatalities of high interest in our society.

We are using broadcasting, publications, outdoor advertising, online media, and other various media to deliver safety messages to the public.


We are sharing card news and infographics through new media, strengthening two-way communication, and expanding a consensus to practice safety and health.






