## Korea's first-ever tower crane practice & training facility scheduled to open

KOSHA held ground-breaking ceremony of practice & training facility for installation disassembly of tower crane elevated on-site applicability or training by installing tower crane actually used at worksites

- A practice and training facility to prevent accidents through comprehensive practice-oriented training on installation disassembly of tower crane, the first-ever of such kinds in Korea, is about to become available.
- 62 KOSHA held a ground-breaking ceremony for "Practice & Training Facility on Installation·Disassembly of Tower Crane" at the Incheon Regional Office of KOSHA located at Bupyeong-gu, Incheon on July 31<sup>st</sup>.

## Korea's first-ever tower crane practice & training facility scheduled to open

KOSHA held ground-breaking ceremony of practice & training facility for installation disassembly of tower crane elevated on-site applicability or training by installing tower crane actually used at worksites

Tower crane, the equipment to lifting construction materials to high altitudes, is being managed in accordance with the Construction Machinery Management Act (facility safety, such as registration and inspection) and the Occupational Safety and Health Act (safety of workers).

- Tower crane accidents usually occur during installation.elevation·disassembly works where the accidents soared in 2016 and 2017.
- Especially in 2017, social outrage was ignited as massive fatal accidents occurred during elevations works at Namyangju, Uijeongbu and Yongin.
  - 3 deaths and 2 injured at Namyangju, Gyeonggi-do (May 22<sup>nd</sup>, 2017) / 3 deaths and 2 injured at Uijeongbu, Gyeonggi-do (October 10<sup>th</sup>, 2017) / 3 deaths and 4 injured at Yongin, Gyeonggi-do (December 9<sup>th</sup>, 2017)

- The government established "Preventive Measures on Serious Tower Crane Accidents" through joint efforts by relevant agencies in 2017 in order to prevent tower cranerelated accidents.
  - Subordinate regulations of the Occupational Safety and Health Act (Ministry of Employment and Labor) were enacted in April, 2018, which stipulates mandatory recording of image records during installation-elevation-disassembly works and reinforcement of training to acquire license on installation-elevation-disassembly of tower crane (144 hours).

KOSHA builds this upcoming practice and training center by injecting the budget of about 5 million USD in order for trainees to gain systematic training on entire procedures of installation disassembly works with tower crane under the safe environment.

- At the outdoor training center (4,345 m²), 3 different types of tower cranes (pin, bolt, ruffing) widely used at construction sites will be installed for the purpose of practices on entire installation-disassembly works.
- The indoor training center (2 story structure with gross area of 998 m²) will be featured with 3 classrooms, 3 discussion rooms and practice room to learn operational principles and inspection methods of tower crane.
- KOSHA plans to finish the construction of training facility by the end of this year and operate training courses for installation disassembly workers of tower crane starting next year.

Park, Doo Yong, the President of KOSHA, said, "I have a high hope that this practice and training facility will contribute to reducing the number of fatalities from occupational accidents by half through outstanding practiceoriented education as the facility is bound to serve as a bridgehead to

prevent accidents occurring during installation and disassembly of tower crane."

## Seeking emergency measures to reduce fatal accidents

Nationwide unannounced inspection launches by 2-people inspection teams for 100 days from July 16<sup>th</sup>

- KOSHA implements an emergency measure to reduce fatal occupational accidents for 100 days between July 16<sup>th</sup> and October 31<sup>st</sup>.
- According to the statistics on occupational accidents during the 1<sup>st</sup> half of this year, the number of fatalities from occupational accidents has been decreased; however, the construction industry accounts for a half of all fatal accidents, and the manufacturing industry continues suffering serious accidents, such as fire and explosion.
  - $\times$  Number of fatalities as of the 1<sup>st</sup> half of 2019 : 503 in 2018  $\rightarrow$  465 in 2019 ( $\triangle$ 7.6%)

Accordingly, KOSHA implements the emergency measures by temporarily switching its occupational accident prevention project to inspection/patrolling practices focusing on prevention of fatal accidents.







### Seeking emergency measures to reduce fatal accidents

Nationwide unannounced inspection launches by 2-people inspection teams for 100 days from July 16<sup>th</sup>

- KOSHA mobilizes over 200 inspection teams comprised of 2 KOSHA employees per team to execute unannounced inspections targeting risk-prone worksites around the nation where fall-trap-suffocation accidents are likely to occur.
  - Most of all, in order to prevent fall accidents responsible for 39% (376 deaths) of all fatalities from occupational accidents last year, KOSHA plans to bring 80% of inspection manpower to construction sites.



- Moreover, by injecting 27 new patrol vehicles for occupational safety, KOSHA aims to perform inspections on the region where construction sites are concentrated.
- For the sites in lack of preventive measures against occupational accidents based on the outcome of such inspections, KOSHA is to request immediate rectifications and also to request competent regional employment and labor administrations for supervision if ever such request for rectification is refused.
- For the purpose of successful implementation of these emergency measures, KOSHA will assign its directors and managers to oversee each region and monitor the progress of those measures.
- Concurrently, KOSHA runs extensive promotional efforts in order to educate the significance of reduction of fatal occupational accidents and encourage fulfillment of preventive measures for occupational accidents during the period of implementing these emergency measures.

Park, Doo Yong, the President of KOSHA, said, "The success of the effort to reduce fatal occupational accidents heavily relies on how to proceed with the occupational accident prevention project during the summer season when fatal accidents mostly occur."

"All executives and employees at KOSHA are determined to successfully reduce fatal occupational accidents by promoting the latest emergency measures," Park noted.







# The first certificate for private enterprise to ATXPERT Safety Experience Center

KOSHA awarded the second certificate of Safety Hands-on Training Center to ATXPERT Safety Experience Center operated by S&I Corporation on July 24<sup>th</sup>.

- Certification by the safety hands-on training center represents a system to cultivate effective prevention for occupational accidents by expanding opportunities for workers to access superb training programs through discovery of outstanding private training centers offering experience and practice-oriented safety and health training.
  - Training centers intending to obtain certification only need to submit an application form to KOSHA, and KOSHA will issue a certificate after comprehensively reviewing the operation plan on safety and health training as well as facility, manpower, equipment and accessibility of the training center.



The latest certificate was the second of its kind after the first certificate was issued to the Ulsan Safety Experience Center operated by the Ulsan Fire Department and the first-ever certificate given to a private agency.







# The first certificate for private enterprise to ATXPERT Safety Experience Center

- ATXPERT Safety Experience Center nested at the space of 1,406m² at the 6th floor of LG Mapo Building is equipped with 22 experience programs at 3 districts, including
  - △ safety experiences (18 programs)
  - △ technical practice (3 experience programs) and
  - △theoretical lecture and emergency treatments (1 experience program)
  - The training is available between 8:30 and 17:30 during weekdays where reservations need to be made in advance.
- When safety and health training under the Occupational Safety and Health Act is given at the ATXPERT Safety Experience Center, the hours of completing the training will be recognized as doubled.
  - At the same time, the center plans to offer a new training program targeting officials in the field of building management business.
- A staff of KOSHA said, "We have high hopes that this certification program is to make tremendous contribution to preventing occupational accidents since the certification program on safety experience training centers offers many workers an opportunity to gain first-hand experience on high quality training on safety and health."
  - Noh, Young Taek, the head of business department at S&I Corporation, said "we will continue making efforts to elevate safety awareness and safety competence for workers by delivering experiences and actual practices regarding harmful·hazardous elements."









# Civic participating innovation group meeting

KOSHA hosted a meeting with the Civic Participating Innovation Group at the meeting room of the KTX Daejeon Station on July 22<sup>nd</sup> to discuss innovation measures for this year.

- The Civic Participating Innovation Group consisting of civic members from all walks of life was launched last June in order to reflect public opinions on the occupational accident prevention projects and operation of KOSHA.
- During the meeting,  $\triangle$  the role and future plan of the Civic Participating Innovation Group,  $\triangle$  the last year's performance and  $\triangle$  the innovation plan for 2019 and governmental directions on innovation were shared and discussed.
  - At the meeting, members asked KOSHA to make better efforts to realize social values and develop innovative ideas to prevent occupational accidents, including  $\triangle$  resolution of blind spots for socially vulnerable groups, such as migrant workers and migrant women through marriage,  $\triangle$  creation of jobs and  $\triangle$  implementation of win-win projects between local communities and small-and-medium-size enterprises.
  - In addition, KOSHA issued letters of appointment to 17 civic members newly appointed this year.

A KOSHA staff said, "We plan to endeavor to improve executive capability concerning innovation assignments, including enhancement of catholicity, improvement of economic viability, expansion of active administration and construction of foundation for fair economy, through activities engaged in by the Civic Participating Innovation Group during this year."

"And based on such efforts, we aim to accelerate innovations which the general public can empathize with and contribute to improving the quality of life for everyone," the staff added.
